- Barbouletos Property Original deed transferring property in 1978 was not recorded until 10/7/2005. The first deed shows a 10 foot easement for utility purposes to the City on the west side of vacated Alba Street. According to the County Assessor both deeds are Warranty Deeds and the easement is valid.
- Water System: Vent covers needed to be removed in the Booster Station. Covers should be removed every May and replaced in October. The thermostat was corrected.
