RESOLUTION AMENDING RATES OF WATER UTILITY OF CITY OF UKIAH

WHEREAS, the Ordinance governing the water system of the City of Ukiah provides that water rates shall be set by resolution; and

WHEREAS, Resolutions #11, 2005-01-04-#1, 2009-03-03-#1 established rates and procedures; and

WHEREAS, the City Council has had multiple meetings and discussions in order to revise the water rates; and

WHEREAS, the City wishes to establish new rates based on meetings and discussions.

NOW THEREFORE BE IT HEREBY RESOLVED WATER RATES SHALL BE AS FOLLOWS:

1.

- 2. If Absent Property Owners do not want to pay water; City will remove meter, cap off water and charge \$180 to reinstall. Regular sewer rate will still apply.
- 3. Vacant lots, including Forest Service RV lots, with water and sewer connections will be charged one half monthly base rate, plus regular monthly sewer charge and reconnect of \$80 will apply.

- 4. Rates will be reviewed yearly and aligned with the Consumer Price Index.
- 5. All other requirements of Resolutions #11 Resolution 2005-01-04-#1 and Resolution 2009-03-03-#1 shall apply unless changed by this Resolution.
- 6. The effective date of this Resolution shall be May 1, 2019.
